Mr. Gonzalez recognized Sheritta Wells, Behavior Program Specialist and Lamyaa Sassi, Program Specialist for their work in helping to develop and put in place a training program to train new hire instructional aides in behavior intervention strategies and Crisis Prevention Intervention in order to be able to better support our students.

Mr. Gonzalez discussed upcoming event: CAC Spring Social Event at Date Elementary School on Friday, March 8, 2024.
